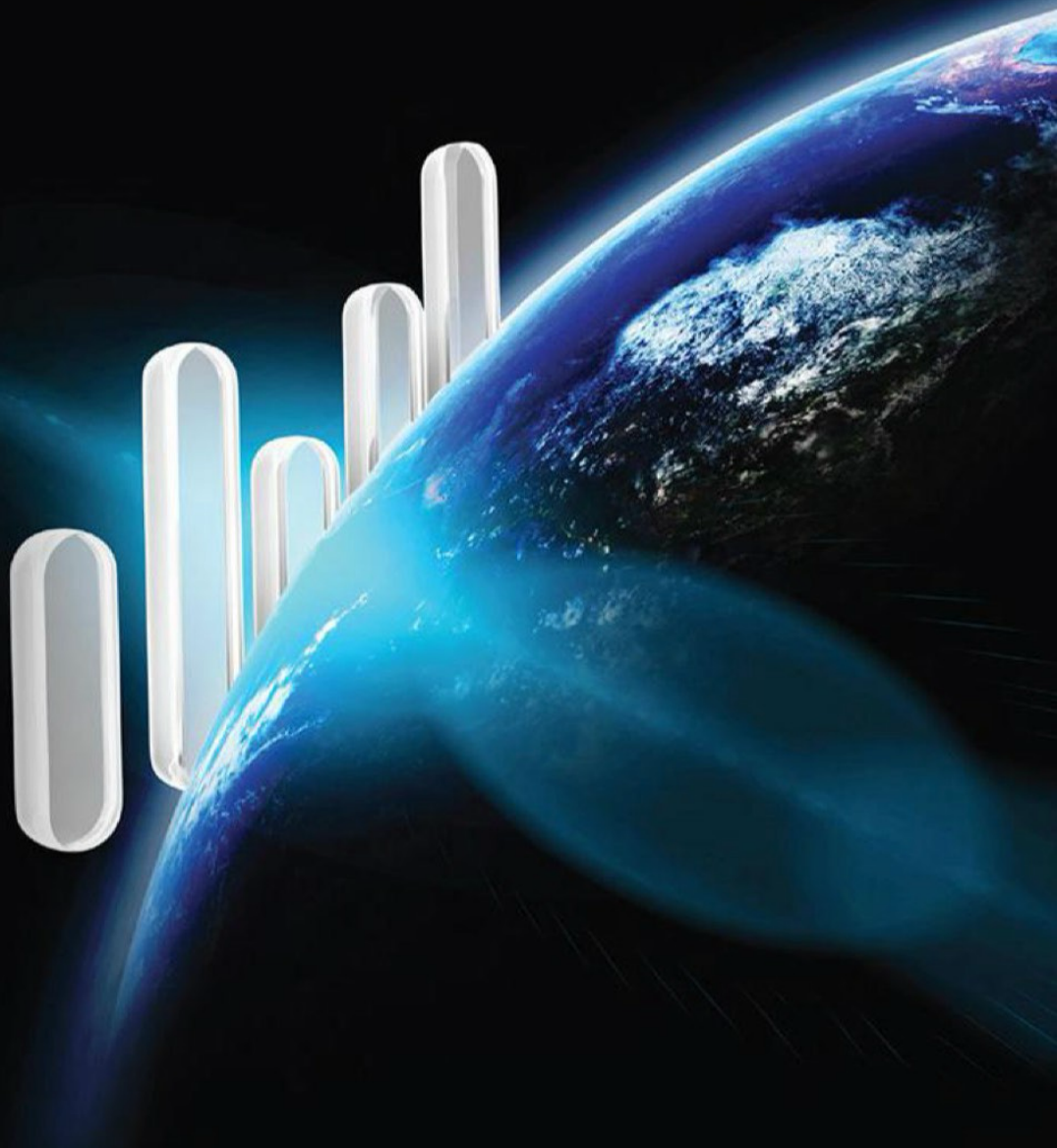
TERMS OF USE
